DIRECTIONS FOR CLINIC AND/OR OUTPATIENT TESTING

These directions are for your upcoming appointment(s) for either a clinic visit or for any outpatient testing associated with this visit. Parking for either appointment is in the **OUTPATIENT PARKING GARAGE**.

Turn in at the traffic light (see arrow on campus map) from Walnut Grove Road into the Baptist Hospital complex. Once you have entered the complex, Baptist Hospital will be on your right. The doctor's office buildings will be directly in front of you and stretch out to the left, Plazas 1, 2 and 3 noted on the outside of each building. Veer to the left (see arrow on map) and follow the road to the right around Plaza 3 (#6 noted on map). Immediately after rounding the building turn right into the entrance to the **OUTPATIENT PARKING GARAGE** which is attached to Plaza 3.

If you are having a test...Enter the building on the bottom floor ("**C LEVEL**"). As you enter the building, you will be in the **OUTPATIENT TESTING CENTER**. Please check in at the desk in this lobby on _____ at _____ to register for the test that is a part of your evaluation.

If you are having a doctor's visit only..... Park as above but enter the building on **LEVEL ONE (1)**, one floor above "C Level" and above the Outpatient Center. After entering the building, veer to the left following the windows around into the 6027 Building. You will be able to see the Outpatient Center below. Our office will be the 1st door on the right after passing all the windows. Please check into the clinic on _____ at _____.

If valet parking, after entering the doctor's building you will be in a large lobby. Take the hallway to the left of the lobby. After passing the Auditorium, our office will be on the left, Suite 114.

Please complete the **New Patient Information Form PRIOR** to your appointment with the doctor. This will help avoid delays in your scheduled appointment time. If possible, please fax this form at least one day prior to your appointment to **901-531-7199** to help us reduce your wait time at this appointment. If unable to fax and time permits, please mail it to the Walnut Grove address listed above.
